President's Corner

Fall flying offers beautiful scenery for trips to see foliage, but pilots must prioritize safety due to shorter days, potential early morning fog, frost, and icing.

#1: Preflight

You've probably heard the saying: Preflight like your life depends on it, because it does! Visually inspect your propeller blades, spinner, and hub assembly. Look for any dents, nicks, gouges, cracks, missing hardware, and signs of corrosion, erosion, or oil leakage.

#2: Preheat Your Aircraft Engine

Preheating your aircraft engine not only to ensures smoother, safer takeoffs but also protects the life of your engine.

When is it cold enough to begin preheating your aircraft engine? Generally speaking, preheating is recommended for aircraft engines that have been cold-soaked to a temperature of freezing or below.

#3: Plan for Reduced Daylight Hours

The changing seasons mean pilots need to be aware of reduced daylight hours and plan accordingly. As a reminder, the clocks will fall back on November 5, 2023, and the sun will set earlier in the evening.


From Fort Wayne

MOSAIC LIVES!

Effective October 22, 2025, pilots who hold a sport pilot certificate or fly under sport pilot privileges in the United States will have access to a much wider range of aircraft they can fly. This reform, known as the Modernization of Special Airworthiness Certification (MOSAIC), was in the works for more than a decade. The final rule was announced during EAA AirVenture Oshkosh 2025.

Top 5 Things to Know About MOSAIC.

- 70 percent of the single-engine piston aircraft fleet in the United States is now eligible to be flown by sport pilots.
- A maximum clean stall speed of 59 knots (67 mph) will be permitted for sport pilot-eligible aircraft.
- Aircraft with up to 4 seats can be flown by sport pilots (increased from 2 seats).
- Sport pilots can fly with up to 2 occupants in the aircraft (pilot plus one passenger).
- There is no longer a maximum weight limitation for sport pilot-eligible aircraft.

MOSAIC also revises the light-sport aircraft category, allowing newer and more capable models of light-sport aircraft to be developed and sold on the market starting on July 24, 2026. It also expands the scope of aircraft available for the Light Sport Repairman Maintenance (LSRM) rating, allowing more nonbuilder owners of amateur-built aircraft to perform their own annual condition inspections and other maintenance on their aircraft.

Government Shutdown and General Aviation

What effect is the month-long shutdown having on general aviation? *Compiled from various sources*.

Air Traffic Control. Air traffic controllers are considered "essential personnel". However, the FAA had fallen behind on training new controllers even before the shutdown. Absenteeism has increased (remember, they're not getting paid until the shutdown comes to an end). As a result, some airports have experienced delays.

Because flight following is provided on a workloadpermitting basis, it may not be as available as it once was. **Online Information**. The <u>aviationweather.gov</u> website is functional, as it provides critical information for pilots. However, the FAA's NOTAM page notes there may be delays in posting recent NOTAMS.

Pilot Training and Check Rides. Available.

Medical Certificates. Airman medical certification is shut down for the issuance of new medical certificates, but "aviation medical examiners may still issue certificates to qualified pilots at the time of a regular FAA physical exam."

Bottom line. Be aware that some services we rely on may be restricted, delayed, or unavailable. Fly safe!
